MultiTrans 7 Patch 7.0.22119.1 – 7.0.22189.1

New Features

1. (54177) Provider and Customer custom fields can be imported through CSV and XML.
2. (73659, 73660) Completed tasks appear on the [Scheduling Timeline](#). The option [Completed Tasks Color](#) was added to the [Settings](#) and completed tasks show on the [Scheduling Timeline](#) in the selected color.
3. (76406) The Provider [Availability Check](#) considers assigned tasks within the validation timeline.
4. (76814) The [Pay\(h\)](#) displays in the Provider [Availability Check](#) regardless of whether the Provider in question has a contract.
5. (75838) Weighted words are rounded to the nearest integer when updated automatically through the [Analysis](#) or by updating the [To Be Done](#) word count.

6. (75488) The ansi-regex library has been updated to version 5.0.1.
7. (75489) The url-parse library has been updated to version 1.5.9.
8. (75490) The adm-zip library has been updated to 0.5.2.
9. (75491) The json-schema has been updated to version 0.4.0.
10. (75493) Tomcat has been updated to version 9.0.62.
11. (69833) Scheduling works correctly across different time zones.
12. (77507) Obsolete options have been removed from display of the [Default Scheduling Settings > Providers](#) tab.
13. (77508) Obsolete options have been removed from the [Timeline](#).
14. (76594, 76726) The [Refresh this page](#) button is always available on the modal [Scheduling Options](#) window.
15. (76513) Formatting of the [Timeline](#) better displays the number of hours remaining.
16. (77484) When a Provider is unassigned from a task, the [Timeline](#) no longer shows the corresponding time as reserved.
17. (77827) On the Providers [Timeline](#), when scrolling to the right or left, the Providers are frozen into place.
18. (77834) In [Settings > Default Scheduling Settings > Provider Update](#), the colors can now be manually adjusted, and this preference is now reflected in the [Timeline](#).
19. (77817, 77818) On the [Schedule > Timeline](#), the default colors have been updated for easier recognition.

20. (77846) Regardless of the project deadline, the task deadline displays on the Provider [Timeline](#).
21. (76593) Fixed issue where previously navigating between days/weeks wouldn't always direct you to the expected corresponding day/week.
22. (75371) The remaining hours for providers is updated in the [Provider Search Availability Check](#).
23. (77874) Regardless of a Provider's contract status the [Pay\(h\)](#) and [Remaining Hours](#) show when performing the [Availability Check](#).
24. (75447) A Provider's level of effort gets calculated when adding the [Task Delivery Date](#) and assigning the Provider at the same time.
25. (70026) – When scheduling a task that must be split over two weeks, any remaining hours that do not fit into the first week are now carried over into the subsequent week.
26. (75524) An [Exceeds Capacity](#) alert has been added when using the [Provider Search](#).
27. (75527) The [Exceeds Capacity](#) alert appears when a provider's hours are assigned through multiple tasks.
28. (78017) The [Task Delivery Date](#) displays correctly in the scheduling [Timeline](#) for completed tasks.
29. (77813) The [Task Delivery Date](#) updates correctly when using the arrow keys to select the delivery hour.
30. (75884) When the [Pay\(h\)](#) is modified manually, the Provider Search does not show the updated value until the modification is saved.
31. (77975) The number of weighted words displays correctly when a Project Manager clicks [Send these Contract Details to assigned resource](#).
32. (75015) An issue of certain rate & quantity combinations not being saved under [Contract Details](#) has been resolved.
33. (75804) [Productivity Template](#) names are unique, disregarding leading or trailing blank spaces.
34. (76035) If a provider already has a manually defined [Capacity](#) for a particular [Service](#), [Domain](#), [Source Language](#) and [Target Language](#), and a [Productivity Template](#) is selected, that [Capacity](#) will not change and will not be linked to the selected template.
35. (76517) [Capacity](#) limits (0.01 and 99999.99) were added to [Productivity Templates](#).
36. (76825) On the [Productivity Template](#), when using the German, French, or Spanish interface, the [Capacity](#) field uses a comma instead of decimal.
37. (77977) In Web Editor, using the [Review in Word](#) does not add invalid/extra tags.
38. (76600) An entire multi-page document in Web Editor can be searched both forwards and backwards.
39. (77646) In Web Editor, [Replace All](#) function includes text that appears prior to the starting point in the document.
40. (77701) In Web Editor, changes made using [Replace All](#) are saved after marking a project as complete.

41. (77704) In XLIFF Editor, the [Replace](#) function can now be used for Superscripted and Subscripted text.
42. (76920) In XLIFF Editor, superscripted text is included when using the search tool.
43. (78092) In XLIFF Editor, fixed error of text being in improper order within a segment following the import from word review.
44. (76167) Cleared text within [Tracked Changes](#) no longer reappearing after logging out and back in.
45. (76634) Target documents are fully exported even if a preceding Web Editor task is not marked as complete.
46. (69952) Enhancements were made to improve TextBase sub-segment search results.
47. (74264) Translated segments remain in the proper location when navigating pages in the desktop client analysis [WordAlign](#) process.
48. (76038) Formatting of the [Approve Tasks](#) in the Project Manager Portal has been updated.
49. (73840) Previous analyses are disregarded when a new analysis processing is calculating the TM statistics.
50. (78028) MIF files convert correctly from SDLXLIFF to XLIFF.
51. (76828) The unique identifier of a new Provider is truly unique.
52. (77592) The [Provider XML Import](#) does not generate an error when there is a space at the beginning of the file.
53. (77676) Access rights remain checked or unchecked when folding or unfolding folders, editing a Providers' permissions.
54. (77684) Custom field text imports are limited to 512 characters.
55. (77713) If a [Provider XML Import](#) or [Customer XML Import](#) fails due to an invalid file, the error messaging has been corrected for all subsequent invalid import attempts.
56. (77487) Proper error messaging displays when importing Providers using XML with invalid tags.
57. (78059) The [Provider CSV Import](#) displays an error message when importing number fields with a space after the number.
58. (76796) Proper messaging displays when importing a customer business unit with no address.
59. (77918) The [File Information](#) display is larger when importing Provider or Customer XML or CSV.
60. (78008) An error message appears when importing Providers with duplicate values.
61. (78026) An error message appears when importing Provider with empty value fields.
62. (74257) Incorrect data no longer appears in the [Module](#) column of the [Customer CSV Export](#).
63. (75793) Consistent error messages display when a Project Manager tries to open a project they have no access to.
64. (76034) The [Customer Notification](#) email template can include instructions to the customer.

65. (73875) Final files are not deleted when [Delete intermediary files](#) only is selected in an [Archiving Plan](#).
66. (76515) Error messaging has been added when the name of a language was left blank when added languages to [Administration > Languages](#).
67. (76516) Duplicate languages are not created when adding a new language to [Administration > Languages](#).
68. (78027) Duplicate values are not created when a new value is added to a Multi Combo Box.
69. (77743) When the word count of any project document is edited to 0 the corresponding [Pay\(h\)](#) is recalculated to also be 0.
70. (77749) When setting a [Task Delivery Date](#), when clicking the [Today](#) button the current time is set.
71. (77854) When setting a [Task Delivery Date](#), the selected time is saved correctly.
72. (77892, 77894) The 500 error no longer appears when the [Provider Search](#) is opened before selecting a task.
73. (77893) The list of Providers opens correctly in the [Provider Search > Update services](#).
74. (76471) Proper error messaging displays when a Trados Studio translation package is not available as expected through the MultiTrans – Studio connector.
75. (76522) Units on a project’s [Document](#) tab are rounded to two decimal places.
76. (76795) When using the [CSV Export](#) multiple languages can be exported at the same time.
77. (77959) When a customer edits a project with [Direct Text Translation](#), the [Direct Text Translation](#) request is no longer duplicated.
78. (77896) The tooltip format has been updated for the [Task Delivery Date](#).
79. (73495) In the Customer Portal, field labels are now dynamic, and margins have been added to avoid overlapping.
80. (65188) A header and footer have been added to the [BI Reports](#) page.
81. (76576) Contract logos and invoice logos larger than 500 pixels are resized when uploaded, to fit available space. This does not affect the logo display in the invoices or contracts themselves.
82. (76748, 76749, 76750, 76753, 76757, 76759, 76762, 76763, 76764, 76760, 76846, 76870, 77649, 77917, 78009) A variety of formatting issues have been fixed throughout MultiTrans (quotation marks, text alignment, colons, cut text, typos and spaces).
83. (75814) The French localization has been updated in the [Invoice](#) section.
84. (76844) The duplicate [Flow Web Services](#) check box on the [Provider > Permissions](#) page has been removed.
85. (76872) The Spanish localization was updated in the [Default Scheduling Settings > Providers](#) tab.
86. (75882, 76725) German localization has been updated in the Provider permissions.
87. (76550) The German and Spanish [Productivity Reports](#) have localized names.

88. (76742) Unnecessary extra space has been removed from the default PCF.
89. (73386) Additional input validation has been added to prevent potential reflected cross-site scripting (XSS) vulnerabilities in the invoicing module.

92. (64845) Potential Denial of Service (DoS) attacks have been blocked in the [BI](#) module.
93. (69400) Additional validation of user roles has been added to the REST API.
94. (63712, 63900, 63901) WCAG – Description added to each title page for MultiTrans.
95. (63713, 63911, 63912) WCAG – A paragraph return was added at the end of all paragraphs on a variety of pages to accommodate screen reader users.
96. (63741) WCAG – A description was added to images for users with screen readers.
97. (63742, 77437) WCAG – Header labels were added for users with screen readers on a variety of pages.
98. (63743, 63745, 63762, 63769) WCAG – Tags were added to all formatting tables to accommodate users with screen readers.

105. (63755) WCAG – Error messages in the Advanced Search window are labelled to accommodate users with a screen readers.

 111. (63770) WCAG – Pagination links for [Assigned Document\(s\)](#) and [Unassigned Document\(s\)](#) are configured as an unordered list to accommodate users with a screen reader.
