New Features

- 1. (MER-434) Google will now send Docs, Sheets and Slides through the new DTP workflow. This means:
 - a. Google Docs, Sheets and Slides will be available directly within Mercury for preprocessing.
 - b. Once preprocessed and converted into Polyglot-compatible XLIFF, this content can be validated through a Polyglot preview.
 - c. When the preprocessing steps are complete, these projects will be handled as standard Polyglot projects using existing tools and processes.
 - d. As each PLP enters the postprocessing stage, users will be notified.
 - e. (MER-516) The postprocessed files are added directly to Mercury (precisely one postprocessed file per source file in the same format as the source content).
 - f. Mercury will change the project workflow status to Complete once all PLPs have been postprocessed.
 - g. Due to the special format of these projects, automated estimates will not be sent.
- 2. (MER-557) Multiple XLIFF files can be uploaded corresponding to a single source file received for preprocessing within a DTP project. For this reason, preprocessed source files vs. reference files require user confirmation upon upload, and users have the opportunity to mark each file appropriately. It may take a minute or two after uploading for the filenames to appear in the Mercury user interface.
- 3. (MER-108) Notifications for existing DTP projects as well as new projects following the DTP workflow have been modified for clarity and simplicity.
 - a. A single notification will be sent when a DTP project arrives in preprocessing stage.
 - b. One notification will be sent per PLP as each PLP reaches the postprocessing stage.
 - c. One notification will be sent per PLP if a PLP is cancelled.
 - d. Notifications will be sent to a different target audience based on the vendor assigned to the project's product.
