Tridion Docs 14 adds semantic AI capabilities and introduces many new features to enhance structured authoring productivity to save you time and money



## Taxonomy Space

Taxonomy Space gives you a centrally managed taxonomy to bundle synonymous terms in multiple languages under one tag – and relate it to other tags. Users can tag content in the Tridion authoring UI, enabling web applications to then use the rich metadata to drive personalization, provide better search, and show content relationships.



## Smart Tagging

Smart Tagging provides you with automatic tag suggestions – drawn from the taxonomy managed through Taxonomy Space. You can auto-tag individual items or a batch of selected items, helping you to be more efficient and save valuable time – all while staying fully in control.

Automatic tagging is available in Collective Spaces, while manual tagging, using managed concepts, works in both the Classic UI and Collective Spaces.



## Simplified review collaboration

Reviewing content is now a lot simpler – you no longer need to mark-up PDF files and send emails. Review Space, the new browser-based user interface, gives you a highly intuitive way to focus on the job of collaboratively reviewing content and providing feedback.



## Semantic search

Semantic search enables users to more easily discover content – regardless of its location or language. Users can perform searches based on partial inputs through auto-search completion, as well as search based on synonyms.

Dynamic filtering capabilities are fully supported and Tridion's GraphQL API provides unfettered access to both the content and the managed taxonomies to build truly amazing digital experiences. Tridion DXD enhances and elevates search experiences when combined with Tridion Docs to create true portal-like applications.



## Better structured authoring experience

It is now easier than ever for anyone to author structured content – allowing occasional contributors and subject matter experts (SMEs) in your organization to contribute their knowledge in the same place.

Draft Space, the new browser-based user interface, provides a structured content approach, while eliminating the need for contributors to work directly with the underlying XML.



### Automated headless content publishing

Tridion Docs has been decoupled from the very beginning so has always been capable of publishing to multiple channels, devices or platforms.

Its out-of-the-box headless delivery allows you to publish to all current output channels – and helps future-proof your content for any new channels that emerge.



### Increased productivity for technical authors

Technical authors now have enhanced search and reporting functions and can now download a publishing report (DITA-OT log) directly from Publication Manager. You can now search for publications straight from Publication Manager and Authoring Bridge. You can also filter by created or modified date – enabling you to locate information faster.



### Easy translation management

You can now choose target publications/ languages and send items for translation from the translation panel itself – thanks to improved translation functionality. Users can see translation information such as where the item has been translated from, and which publications the item has been translated to.



### Content Importer

Content Importer has a new user interface that simplifies importing content and translations. You can now import translations directly from file systems for better usability and security. Track progress, pause/resume, or restart unfinished imports and finish a full import with logging. You can even stop an import in the case of content errors. The new importer allows binary file types such as PDF, DOCX etc., making it extremely versatile for your teams and organization.



### New Add-ons and Connectors

Connectors enable fast and standardized integration to various external systems, and Tridion Docs 14 now works with the following connectors.

#### SharePoint 365

This connector makes it possible to publish documents (Word, PDF etc.) to SharePoint 365 directly from Tridion Docs. Publication metadata information in Tridion Docs can also be published alongside the document. The connector is added to the standard publishing pipeline, allowing documents to be formatted before being delivered to SharePoint 365.

#### Vevea Vault

This connector to Veeva Vault enables organizations, such as those working in Life Sciences, to easily store and then electronically sign final outputs in this market-leading document management system – ensuring the whole organization can access Veeva Vault from a single point. Veeva Vault also comes with extensive document workflow support.
