The People's Republic of China built the Great Firewall of China (GFW) to regulate the internet domestically. It blocks access to selected foreign websites and slows down cross-border internet traffic. Delivering websites from outside of China results in slow and poor-quality digital experiences for visitors from within China.

In addition, information about hosting and registering a website in China is difficult to navigate and many encounter conflicting information.

DX Accelerator for China combines the best of your current Tridion implementation with Content Delivery for Chinese content on the Alibaba Cloud.

### Solution overview

Our DX Accelerator for China is a comprehensive solution for delivering content in China. In partnership with the Chinese market-leader in cloud solutions, Alibaba Cloud, it helps you:

- Navigate the different regulatory requirements in the many regions of China
- Understand the detailed steps of the registration process
- Obtain your ICP filing / licensing more easily and efficiently
- Launch a dedicated Chinese content delivery endpoint, connected to your existing Tridion environment

If desired, you can also deploy your Chinese websites on other providers such as AWS and Azure.

### How the solution works

Our DX Accelerator for China provides a Tridion content delivery endpoint inside the Great Firewall of China. Content is published from your existing Tridion authoring environment to this new target environment and is stored securely in a local database on the Alibaba Cloud. Your presentation servers are deployed to a Chinese hosting facility so website visitors requesting pages are directed to this local endpoint. This locally hosted Chinese website serves up the web experience without any firewall delays.

Employees working on your local Chinese websites log into your existing authoring environment which remains hosted where it is today, outside of China.

### Background on ICP filing / licensing

You need to take care of many formalities in order to run a web presence in China. These include a process called Internet Content Provider (ICP) filing/licensing.

It represents a license from the Chinese Government needed to operate a website in China. This regulation has been around since September 2000, and is enforced more aggressively lately.

#### ICP filing:


- Permits operation of an informational website, such as a marketing website
- Requires your organization to have a legal, physical presence in China
- Requires web hosting in China

#### ICP license:

- Permits operation of a transactional website, such as an online store offering goods or services
- Requires a majority owned (>50%) Chinese business
- Requires web hosting in China
